CPEN Review

The CPEN (Certified Pediatric Emergency Review) is a comprehensive 2 day review to assist the RN in preparation to sit for the CPEN examination.

Topics Presented: The following concepts are integrated throughout the review course and appropriate to the stated task: Diversity (cultural, ethnic), Health promotion and injury prevention, Communication, Discharge teaching, Growth and development, Collaboration with other health care providers, Pharmacology (e.g., medication reactions), Conflict resolution, Medication administration (e.g., weight based calculations), Customer service and Evidence-based practice.
